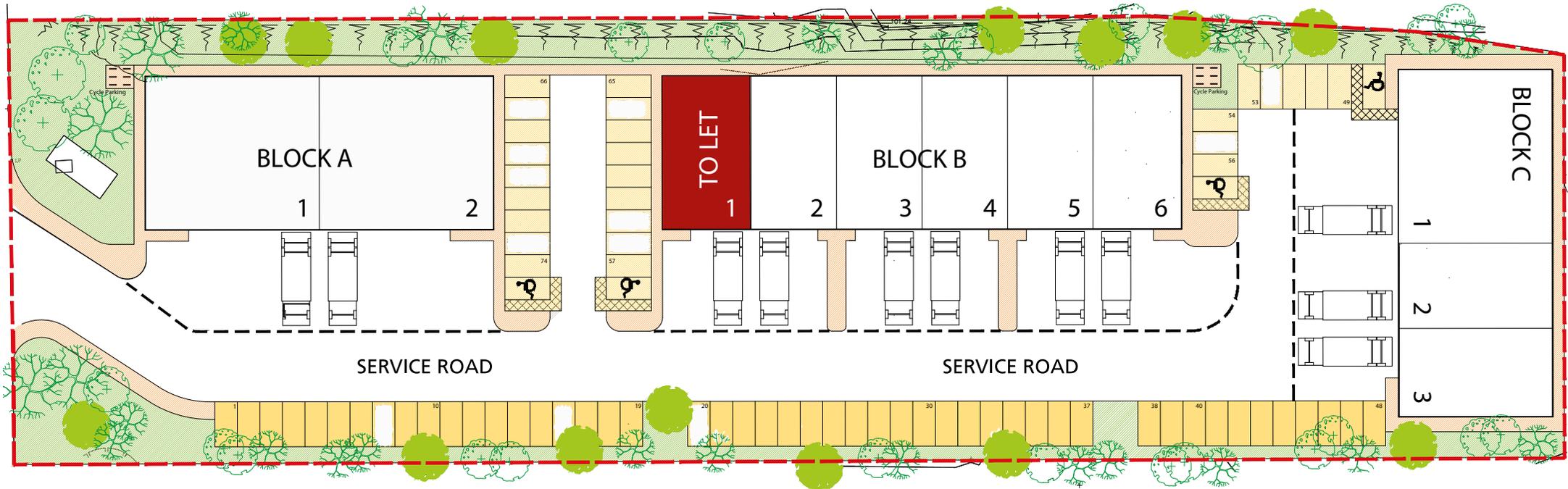

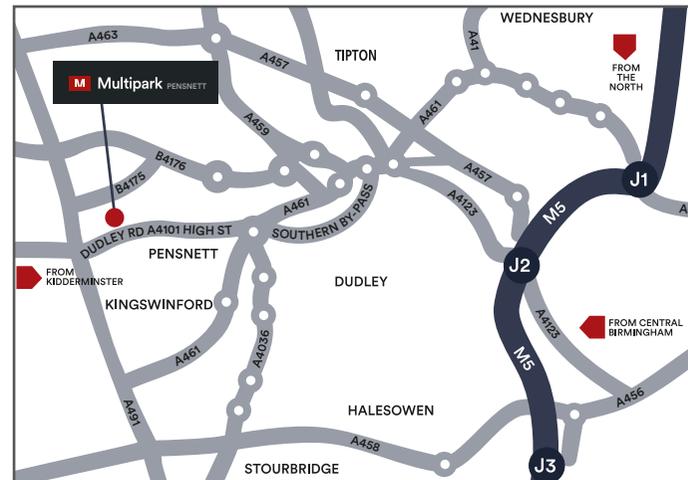
## Location - DY6 7FT
